Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: **Waterways 1, 2, and 3 are man-made ditches with ephemeral flow regimes. Historical aerial imagery available in Google Earth shows that Waterway 1 was constructed circa 2018 in uplands. Prior to the construction of the feature, the Review Area was used for pasture or agricultural land. The time of construction for Waterways 2 and 3 is unknown. Historical U.S. Geological Survey (USGS) topographic maps from 1891 to the present day do not show blue**

lined streams in the Review Area. The majority of the Review Area is underlain by Carney Clay soil types which typically occur in uplands. A small portion of Waterways 1 and 3 are underlain by Padigan Clay, which is classified as hydric. The U.S. Fish and Wildlife's (USFWS) National Wetland Inventory (NWI) has not mapped aquatic features in the Review Area.

Waterway 1 enters the Review Area from a subsurface culvert pipe under Crater Lake Avenue that drains stormwater from an industrial property to the east of the roadway. It exits the Review Area via a subsurface culvert under Crater Lake Highway. Waterway 1 does not drain wetlands or tributaries; its hydrologic inputs are from incidental rainfall and stormwater runoff from the surrounding roads and businesses. The ordinary high water mark (OHWM) of Waterway 1 was identified solely on a change in sediment. No other OHWM indicators were observed during the wetland delineation survey. Vegetation has colonized the bed and banks of Waterway 1, including horseweed (*Erigeron canadensis*), a facultative-upland species; yellow starthistle (*Centaurea solstitialis*), dogtail grass (*Cynosurus echinatus*), and medusahead (*Taeniatherum caput-medusae*) which are upland species; and perennial ryegrass (*Lolium perenne*), a facultative species. The presence of upland vegetation both landward and waterward of the OHWM indicates that the feature lacks surface water for the majority of the year. Google Earth Pro aerial imagery from 2018 to the present day, wetland delineation data forms completed in May and June 2021, and photographs of the Review Area taken in August 2021 do not show surface water in the channel. As such, the Corps determined Waterway 1 is not a relatively permanent water. Waterway 1 was excavated wholly in uplands, drains only uplands, and has less than relatively permanent flow and is not considered a water of the U.S.

Waterway 2 enters the Review Area from a subsurface culvert pipe under Crater Lake Avenue. Waterway 2 flows toward the southwest corner of the Review Area and then begins to flow northward where it empties into Waterway 1. Waterway 3 enters the Review Area from the northwest corner of the Review Area and flows south toward Waterway 1. Waterways 2 and 3 do not drain wetlands or tributaries; their hydrologic inputs are from incidental rainfall and stormwater runoff from the surrounding roads and businesses. Upland vegetation has colonized the bed and banks of Waterways 2 and 3 and there is no defined OHWM, both of which indicate that the features lack surface water for the majority of the year. Google Earth Pro aerial imagery from 2018 to the present day does not show surface water in the features. As such, the Corps determined Waterways 2 and 3 are not relatively permanent waters. Waterways 2 and 3 were excavated wholly in uplands, drain only uplands, and have less than relatively permanent flow and are not considered a water of the U.S.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
